DURING THE YEAR ENDED DECEMBER 31, 2025, HFF GAVE GRANTS OF \$6.13 MILLION TO NONPROFIT ORGANIZATIONS IN 60 COUNTRIES AROUND THE WORLD TO HELP OVER 300,000 CHILDREN. 40% OF THE ORGANIZATIONS HFF SUPPORTS ARE ORPHANAGES, 17% ARE COMMUNITY CENTERS, 15% ARE COMMUNITY IMPROVEMENT ORGANIZATIONS, AND THE REST ARE AFTER SCHOOL CENTERS, ELEMENTARY/SECONDARY SCHOOLS, HOMELESS SHELTERS, HOSPICES, HOSPITALS, PRESCHOOLS, AND WOMEN'S SHELTERS.

\$3.27 MILLION OF HFF'S GRANTS WENT FOR FOOD SUBSIDY, \$1.046 MILLION FOR NUTRITION STAFF, \$343,000 FOR NUTRITION EDUCATION, AND THE REST FOR CAPITAL SUPPORT, GENERAL OPERATING, KITCHEN RENOVATIONS AND OTHER.
